REGISTRATION – STEP 1



This document is a step-by-step guide outlining how to register as **Standard Account Supplier** in Ariba.

Be aware of:

If you already have an Ariba Standard Account used for other customers then you can use this existing account for business with Allianz if you like.

This use case is included in this guide as well.

You will receive an e-Mail from the Ariba system relating to your first purchase order from Allianz.

When you are ready to view and start processing your first order, please press the blue **"Process order"** button.

Your web browser will start and will load the Ariba supplier login web page...

REGISTRATION – STEP 2



Here you have the choice to:

a) Register: Create a new account for Ariba Network in case your company doesn't have any account already. Only IF you like to have a separate new account for business with Allianz you should create a new one.

b) Log in: Log in with an existing Ariba Network account of your company if you already have an account that you want to use for business with Allianz.

Ariba Network tries to detect if there are already existing accounts from your company.

In case it finds existing accounts it shows a "Review Accounts" dialog.

You can skip this dialog if you already know which is the correct existing account by clicking the X.

Be aware of:

The first purchase order and login process will determine which account can be used for business with Allianz for all subsequent orders and invoices!

Check within your Sales department and Accounts/Receivable department which Ariba Network account should be used **before** logging in to any account or creating a new one!

REGISTRATION – STEP 3



Be aware of:

The following steps apply if you chose to create a new account. If you decided to use an existing account of your company then skip the following steps. There is no registration needed then.

If you decide to select “**Register Now**” on the Ariba Network you will be asked to enter some information.

a) Company information: This is general information about your company. For the most part these are already pre-assigned from the order. Please check the data and change it if necessary.

b) User account information: This is data about the main user of the Ariba Network Portal on the supplier side.

All fields marked with an asterisk must be completed.

REGISTRATION – STEP 4

You can enter more information about your business by clicking on **“Tell us more about your business”** but this is not mandatory and can be done at a future date if required.

Finally, you must acknowledge that you have read and agreed to the **Terms of Use** and the **SAP Ariba Privacy Statement**.

By pressing the **“register”** button you complete the registration.

REGISTRATION – STEP 6



You will then see your first order in the web interface and can then start working on an order confirmation* or invoice for your first order if you like.

Additionally, you will receive a confirmation email from Ariba Network.

If you push the done button you will be directed to actual home page of the standard account.

* if an order confirmation is needed before delivery should be aligned with the respective procurement department of the Allianz entity that sent you the order.

REGISTRATION – STEP 7



Here you see the actual home page of your Ariba Network standard account.

Be aware of:

With a standard account (free of charge!) you can only DISPLAY an overview of your incoming purchase orders on the home page.

You can't process the orders (order confirmation* or invoice) from here directly.

In order to directly process orders from the home page you would need to upgrade to an enterprise account (not free of charge!).

You can process your order by again opening the received order email in your email application and clicking the PROCESS button.

In case you lost the original email you can log in to your account (<https://service.ariba.com>) and re-send a copy of the order to your email box.

* if an order confirmation is needed before delivery should be aligned with the respective procurement department of the Allianz entity that sent you the order.
